How does it work?

We have assessed this organisation as being eligible for funding from Stewardship. You can make gifts into an account with Stewardship on which we reclaim tax worth around 25% under Gift Aid (providing you are a UK taxpayer). We make regular payments to this organisation, having considered the gifts received from supporters such as yourself.

Can anyone do it?

You need to be a taxpayer and pay enough income tax (at whatever rate) or capital gains tax in each tax year to cover the tax reclaimed on your giving.

If you are not a taxpayer, you may still make non gift

What are my obligations?

There is no legal commitment to continue. If for any reason you need to stop, you can.

What if I am a higher rate tax payer?

There's good news for you! Higher rate tax payers receive extra relief claimed through their tax return.


